#3: Submitting Your Final Competition Piece

Every publication has the same submission deadline. Make a note in your calendar or planner. Don't wait until the last minute to submit, even with the deadline, you should prepare yourself a minimum of 30 minutes-1 hour prior to the due date/time. It is YOUR responsibility to submit on time. **The due time is 9 a.m. Central time on September 1, 2023.** There will be NO EXCEPTIONS for anyone trying to submit late. There is a 5 minute "grace period" in the drop box built in. Don't wait until the last minute.

1. Once you have decided to participate in the Write-On Competition, **you must submit your registration information for the competition via the Tulane Intranet** before you can access the Journal Write-on Competition-FINAL SUBMISSIONS TWEN page.
2. The **Tulane Journal Write-On-FINAL SUBMISSIONS** TWEN page is password protected. To receive the password, you **must submit** your registration information via the Tulane Intranet

and the password will be sent to you in an auto-reply email. Once you receive that you can add the course like any other course on TWEN.

Click Submit to submit your competition pieces to the 1L Brief Packet link, as well as your technical edit & personal statement to the correct drop boxes.

Anonymous ID is your Tulane 9-digit splash ID. Enter that #. Double check that your number is 9 digits and correct! Incorrect IDs may result in a delay of grading your submissions. If your ID cannot be verified via your registration your submission may be disqualified.

Note: Your professor is using anonymous grading. You should include only your anonymous ID on your submissions. Please ensure that your name does not appear anywhere on your work or in the file properties embedded with your submission. ?

If you have questions about removing potentially identifiable information (metadata) from your file, please consult the help file for your specific word processor or contact the manufacturer of the software you used to create the document.

Please use your Tulane Splash ID for your Anonymous ID.

Also remove anything in the properties of your document that may identify you.

Anonymous ID

Use the BROWSE option to upload your competition piece. All submissions are time stamped & dated. You **DO NOT** need to include a message; just upload your file. Do this for each competition you are participating in. You may submit multiple times, BUT only the FINAL submission will be considered. **All earlier versions will be deleted and not opened.** It is in your best interest to submit ONLY one piece and not submit over and over again. You will likely end up making an error in what you submit. We are not responsible if the final submission you make is the wrong one. You will be allowed to submit past the deadline, but it will be noted in **RED** and it will be up to the publication whether or not to accept your submission. Technical difficulties **must** be reported **before** the deadline.

Additionally, you might want to save your final competition piece to a **flash drive or separately in an online folder** so that you don't accidentally submit the wrong document.
